## **CONSENT AGENDA**

\*\*\*\*\*MOTION to approve the Consent Agenda was made by Robert Munsey, seconded by Wade Blankenship with Frank Chandler voting yes and Danny Kinder absent from the meeting. Items within the Consent Agenda included: 1) minutes of the regular meeting of April 22, 2003, continued meeting of April 28, 2003 and continued meeting of May 13, 2003; 2) additional bills for the month of April 2003 in the amount of \$2,298.03; and bills for the month of May 2003 in the amount of \$233,167.98; 3) payroll for April 30, 2003 and May 16, 2003 at a total amount of \$110,991.33 and 4) reports of the Treasurer, Sheriff, Commissioner of Revenue, Recycling Program, Building Official, Public Works and E-911 Coordinator.

#### VIRGINIA DEPARTMENT OF TRANSPORTATION

Frank Phipps updated the Board in regard to the ongoing projects throughout the county to include; 1) the easements needed for the Ridgeway Subdivision; 2) the culvert installed with connector box on Rt. 52 Bastian; 3) plant mix put on to help alleviate the problems at the Rt. 169 bridge; 4) Rt. 608 awarded to Hunter Paving; 5) Rt. 52 bridge in Bland approximately one half finished; 6) Rt. 609 prefab bridge installed; 7) stone surface on Rt. 609 to be done with state forces; and 8) guardrail being installed upon Rt. 621. Mr. Phipps advised he would be sending

the proper forms to the county to obtain the two easements needed for the Ridgeway Subdivision road improvement project.
