CALL TO ORDER

Chairman Mr. Blessing called the continued meeting to order.

VICTIM WITNESS

Judy Cassell, Victim Witness Program Director presented information regarding the existing Victim Witness program and requested a 10% county match be included within the county's 06-07 budget in order to continue the Victim Witness program, which is to be funded at 80% from the Department of Criminal Justice, July 1, 2006.

SHERIFF DEPARTMENT

Sheriff Jerry Thompson spoke to the board with an explanation of the budget submitted and requested 100% revenue from ticket monies to support his office. Courtroom security funds and allowable expenditures were discussed.

COMMISSIONER OF REVENUE

Cindy Wright, Commissioner of Revenue requested salary increases for her department personnel, requested that the county increase the part time position to full time, effective July 1, 2006, and expressed the desire to purchase the CAMRA software.

GENERAL DISTRRICT /JUVENILE COURTS

Jill Baker, Clerk appeared to the board with the request of monies within the 06-07 budget to purchase a shredder and funds for phone service.

TREASURER

Joann Shewey, Treasurer requested assistance regarding salaries of the two deputies within her office, an increase to her travel, training and education line items.
