CALL TO ORDER

Chairman Henry Blessing called the May 2006 regular meeting to order.

INVOCATION

The invocation was offered by Vice-Chairman Jason Ramsey.

PLEDGE TO FLAG

Chairman Mr. Blessing led the pledge alliance to the flag.

MAY 23, 2006 MEETING AGENDA APPROVED

*****IT WAS THE CONSENSUS of the Board to approve the May 23, 2006 meeting agenda with the addition of the Relay for Life Entertainment permit application.

CONSENT AGENDA

*****MOTION to approve the Consent Agenda which consists of the minutes of the April 25, 2006 regular meeting; continued meetings of May 10th, May 16th and May 17, 2006; bills in the amount of \$162,938.04; the May 1, 2006 and May 16, 2006 payrolls totaling \$137,176.40; reports from the Treasurer, Building Official, E-911 Program Manager, Public Works Director, Meals & Lodging and Recycling was made by Jason Ramsey, seconded by John Thompson.

SCHOOLS JUNE 2006 REQUISTION APPROVED

Superintendent Don Hodock advised that within the 2005-2006 school year, the ADM was reduced by 15 students, resulting in state funds being lost and requested the schools be allowed to spend the \$30,000+ in local monies budgeted on July 1, 2006, which would be over and above the required local match.

Supervisor John Thompson requested that the school system look into a PPEA option before any monies are spent on the design of a school.

With the understanding that the \$30,000 has been budgeted, and the school system will have to pick up the additional \$60,000 that the state is not going to send down, *****MOTION to approve and appropriate the June 2006 school board's request in the amount of \$2,122,071.00 was made by John Thompson and seconded by Jason Ramsey.
