COUNTY ADMINISTRATOR'S ITEMS

Dr. Workman recommended to the Board the proposed FY19 budget of \$18,046.664 with no increase to any tax levy proposed. The line item for the JAMS program was increased to \$2,000 with the condition that the contribution is a match to Mountain Home funding up to \$2,000.

ADOPT CANNERY FEES

*****Motion to adopt cannery fees for the 2018 season as follows:

- Out-of-County Fee – per season (for profit) \$30.00
- Out-of-County Fee – (personal) Usages plus 10%
- Processing Fee - \$0.35 per can with Minimum fee of \$3.00
- Kettle Usage Apple Butter (personal use) \$6.00
- Kettle Usage (for profit) \$12.00
- Misc. (vegetables and fruits, etc.) \$3.00
- Tins each: Pints \$0.80 Carton \$0.75; Quarts \$1.10 Carton \$1.00; Gallon \$2.77 Carton \$1.80
- Other foods processed \$0.35 per pound.
