Informational Items

Eric Workman asks the board of supervisors to be aware that currently the county is limited to a 2% tax levy on transient occupancy tax on hotels, motels, boarding houses, travel campgrounds and other facilities offering guest rooms rented out for continuous occupancy for fewer than 30 consecutive days. There is a provision in the Code of Virginia (58.1-3819 that allows localities to levy a 5% transient occupancy tax. The requirement is that the additional funds obtained for the 3% increase have to be spent on tourism based initiatives. The current levy generates approximately \$3,100 annually. The General Assembly has to take action to add the county to the list of counties able to participate in the program.

Workman also presented the board with Community Profile from the Virginia Employment Commission.
